Lepu Biopharma Co., Ltd. (the "Company") has received the filing notice from the China Securities Regulatory Commission and the approval from The Stock Exchange of Hong Kong Limited (the "Stock Exchange") of the conversion of 54,268,364 domestic shares of the Company (the "Domestic Shares") into H shares of the Company (the "H Shares") and their listing on the Stock Exchange, as disclosed in the announcements of the Company dated 28 May 2025 and 19 June 2025, respectively. The relevant conversion was completed on 21 July 2025, as disclosed in the announcement of the Company dated 21 July 2025. The listing of the converted H Shares on the Stock Exchange commences on 22 July 2025.

The opening balance as at 14 July 2025 was 1,750,171,474 H Shares and 54,268,364 Domestic Shares, amounting to a total of 1,804,439,838 issued shares of the Company. Following the conversion, the H Shares increased by 54,268,364 shares, while the Domestic Shares decreased by 54,268,364 shares. The total number of issued shares of the Company after the conversion remains unchanged, comprising 1,804,439,838 H Shares.
